Rules and Regulations

1. The exhibiting artist must occupy his or her exhibit space and be present during the festival hours for the entire three days of the festival. Artist must preside over sales. No subletting of space is permitted.
2. All work must be original art that has been personally created by the exhibiting artist. The display and sale of imports, manufactured items, or items that are produced with the use of commercial kits, molds, patterns, forms or other commercial production methods is not permitted. This rule will be strictly enforced.
3. Limited edition prints, with no more than 750 prints in the edition, are allowed only if they are prints of artwork executed by the exhibiting artist and have been properly signed and numbered. These limited edition prints cannot constitute more than 40% of the artwork for sale.
4. The District at Green Valley Ranch retains the right to use digital images, slides and photos submitted by the artist in advertising promotions and publicity for the festival and artist's signature on the festival application evidences artist's acceptance of this term and condition.
5. Exhibiting artists are responsible for the delivery, set-up and removal of their displays and materials. Displays must be sufficiently sturdy to withstand weather and crowds. All tents must be white. Tents must be of flame-retardant materials and each leg of the tent must be properly weighted with a 50 lb. weight. Dollies required for moving displays and materials in and out of the show are to be provided by the exhibiting artist. All pertinent fire codes, laws, ordinances and regulations pertaining to health, fire prevention and public safety are to be strictly obeyed. Exhibits not meeting the approval of The District at Green Valley Ranch ART WALK are prohibited and The District at Green Valley Ranch may, at its sole discretion, prohibit any activity, conduct or display deemed not in the best interest of the festival.
6. Set-up of the festival will begin at approximately 1 PM Friday, but only after all exhibitor spaces have been marked and approved. All exhibitors must check in at the Festival Information Booth to obtain booth space number. Vehicles may be temporarily parked in designated loading areas for purposes of unloading and loading only. No vehicles may be brought onto "Main Street" in The District. All vehicles must be removed from the loading area as soon as unloading or loading is completed so as to keep the area open for other exhibitors to also move their goods in and out. After unloading, oversized vehicles are to be parked in the designated parking areas. Vehicles remaining in the loading areas after this time will be subject to being towed.
7. Take down of the festival is to take place immediately following the end of the festival, which is at 4 PM on Sunday. **All exhibitors must check out at the ART WALK Information Booth and must provide their sales figures. Artists without a Nevada Taxpayer ID Number must pay their sales tax at that time.** Failure to report sales figures and pay taxes will result in disqualification from future shows. All displays and materials must be removed as soon as possible and removal must be completed no later than 8 PM on Sunday.
8. Payment in full is due at the time of application either by check or by a Mastercard, Visa or AMEX credit card. If payment is made by check, separate checks are to be sent for the \$25 application fee and for the exhibit space fee. No fees will be refunded after applicants have been accepted into the festival. Space fees will be returned to all applicants not accepted into the festival. The \$25 application fee is not refundable. A \$35 fee will be charged for all returned checks.
9. The District at Green Valley Ranch ART WALK will not be liable for refunds or any other liabilities whatsoever for failure to fulfill these terms and conditions, due to unusable condition of the area in which the festival is to take place. These conditions include, but are not limited to fire or other calamity, any act of God, public enemy, strikes, statutes, ordinances of any legal authority or any cause beyond the control of The District at Green Valley Ranch ART WALK. Insurance is required and must be obtained by the exhibiting artist at his own expense. The District at Green Valley Ranch ART WALK assumes no risk.
10. **Exhibiting artist is responsible for the collection and remittance of State of Nevada Sales Tax to The District at Green Valley Ranch ART WALK at the end of the festival on Sunday.** Sales figures are to be reported and sales tax paid at check out. (See #7 above) All sales tax payments must be made by check or money order. No cash or credit card payments can be accepted. There are no exceptions to these rules. Failure to abide by these rules will result in disqualification from future shows.
11. No waivers, modifications or amendments shall be valid unless approved in writing by the director of The District at Green Valley Ranch ART WALK. Venue for all legal proceedings arising from violations of these terms and conditions must be initiated in Clark County.
12. **Applications must be received NO LATER than AUGUST 31, 2010. Incomplete applications will be returned. Notification will be mailed SEPTEMBER 6, 2010 of acceptance or non-acceptance to ART WALK.**
13. Acceptance in previous shows does not guarantee acceptance in future shows. Please do not call to inquire about status of acceptance. Any and all decisions made by the Jury are final.
